<u>Purpose</u>

The purpose of this policy is to protect the interests of AUGS by: (a) preventing the personal benefits of volunteer leaders from influencing their duties to AUGS, (b) protecting AUGS competitive position, (c) preventing conflict of commitment, and (d) avoiding actual, potential or perceived inappropriate/undue influence of related professional associations.

Policy Statement

In order for AUGS to further the clinical, educational, scientific, and charitable purposes for which it was organized, and to maintain the reputation in which it is held by the public and the urogynecology community, it is important that AUGS decisions and actions not be influenced unduly by any special interests of individual members.

AUGS depends on volunteers to shape the initiatives that provide value to members. Recognizing that many members, including Board members and volunteers, have relationships with related professional associations, it is important to identify actual or potential conflicts of interest which might improperly bias decision making. As such, the AUGS Board of Directors has adopted specific guidelines for key society leaders along with a formal system for identifying, disclosing, and managing potential conflicts of interest.

Duty to Disclose

All AUGS volunteers must disclose all actual, potential, or perceived conflicts of interests during their course of service to AUGS in accordance with AUGS Disclosure Policy.

Key Society Leaders

In addition to being required to disclose all actual or potential conflicts of interests with related professional associations, AUGS has set the following guidelines and restrictions for key society leaders who have influence on the Society's programs and policies.

Appendix

Definitions

The following are definitions and examples for terms that are used in this policy.

§ **Conflict of Interest:** A conflict of interest may exist when the personal, professional, financial, or other interests of a volunteer leader may influence, or appear to influence, the judgment or conduct of that volunteer leader in a manner that may bias decision making.

§ **Related Professional Associations:** Related professional associations include national and international professional societies whose principal interests include urogynecology and reconstructive pelvic surgery including but not limited to American Urological Association (AUA)/Society of Urodynamics, Female Pelvic Medicine & Urogenital Reconstruction (SUFU), International Continence Society (ICS), International Urogynecological Association (IUGA), Society of Gynecologic Surgeons (SGS), and American Association of Gynecologic Laparoscopists (AAGL). It does not include national certifying organizations like American Board of Obstetrics and Gynecology (ABOG) and American Board of Urology (ABU).
