Expected Commitment  Committee Composition	The committee meets bi-monthly via conference call. Committee members are expected to review all agenda/materials prior to each meeting, attend the conference calls as scheduled, and engage with AUGS social media posts (likes, shares, comments, etc.)  The estimated monthly time commitment is three hours.  Up to six people plus the Chair and <i>Urogynecology</i> Journal Social Media Editor will support the activities of the Social Media Committee. One position on the Committee should be filled by a junior member who is less than five years post training. An AUGS Board member will serve as a liaison to this Committee.
Committee Terms	All committee members serve a one (1) year term and are eligible for reappointment for up to two additional consecutive terms (up to three years of service). Terms run January 1 – December 31. The Committee Chair and Vice Chair each serve a three-year term.
Selection/ Appointment	Members are appointed by the AUGS Governance Committee with input from the Committee Chair. The Committee Chair is selected by the Governance Committee. Committee member selections are approved by the Board.
